

AMADA is a body responsible for maintaining integrity in sport, centralizing, and developing knowledge and practice, providing coordination of all elements of doping prevention, as well as monitoring, detecting, investigating, and prosecuting anti-doping rule violations. AMADA is a single focal point for athletes, sports organizations, law enforcement and other stakeholders with regards to doping-related matters. AMADA prevents the threat of doping and implements policy to achieve fair sporting

performances and results in Azerbaijan and to promote zero tolerance approach for doping among athletes, their support personnel, administrators, officials, and other stakeholders at all levels, as well as to achieve a safe, fair and inclusive sports environment.

AMADA's 8 main areas of activity are as follows:

To be involved in forming public policies in the field of anti-doping 01 and ensure their implementation, as well as monitor compliance with the legislation and regulations in force;



To ensure development of the domain of fight against doping;



To implement anti-doping program and take measures aimed 03 at the fight against doping, inter alia, prevention of illicit trafficking of doping;



To organize and ensure coordination of activities in the field of 04 anti-doping with relevant bodies/institutions;



To organize and implement doping control, inter alia, sample 05 collection, transportation and analysis of samples;



To promote participation in doping-free sport in order to protect rights and health of athletes as well as athlete support personnel, and to raise awareness in order to discourage the practice of doping in sport;



To investigate and ensure prosecution of anti-doping rule violations;



To ensure mutual cooperation with the World Anti-Doping Agency, international sports organizations, anti-doping organizations and other international bodies/institutions operating under the the auspices of international conventions in the field of anti-doping, which Azerbaijan is a state party to.





Athletes Advisory Commission

AMADA places special importance on having athletes' voices heard. AMADA considers it important to involve athletes in the fight against doping, engage them in collaboration and enable them to contribute to levelling the playing field. In 2019, formation of the Athletes Advisory Commission was initiated with the aim of involving athletes in the anti-doping activities, enabling them to be represented and to contribute to this process. The Commission, which includes influential athletes from various sports, has been in operation since that year and contributed to the country's anti-doping efforts. Athletes Advisory Commission was officially established on January 21, 2020. The mission of the Commission consisting of 12 members, is to represent athletes within AMADA and develop recommendations on protection of athletes' rights and promotion of clean sport. The duties of Commission mainly consist of supporting the core mission, leading, and managing specific athlete-related projects, serving as a liaison between athletes and AMADA and representing Commission at different antidoping events. AMADA discusses emerging anti-doping issues with the Commission, and collaborates to incorporate the views of athletes into its work. Influential athletes from diverse sports are represented in the Commission. On August 12, 2020, pursuant to the Statute of the Commission, the election of the chair and deputy chair was held. Two-time Paralympic Judo Champion Ilham Zakiyev was unanimously elected as a chair and freestyle wrestler, threetime world champion and Olympic bronze medalist Haji Aliyev was elected deputy chair of the Commission.

Athletes Advisory Commission makes an important contribution to the protection of values of clean sport through its activities and represents the athletes at AMADA.







NUMBER OF TEST PER MONTHS






Whereabouts information plays an invaluable role in effective planning and no advance notice testing. Athletes included in AMADA's Registered Testing Pool undergo the appropriate training on the importance of providing accurate, timely and complete information, as well as on the legal consequences of filling failure and missed tests. According to the International Standard for

Testing and Investigation, selection of Athletes included in the Registered Testing Pool of AMADA are based on the criteria set by AMADA. Registered Testing Pool covers Athletes in various categories. They are tested at least 3 times a year out-of-competition period.



AMADA COVID-19 pandemic protection measures

COVID-19 undoubtedly affected the antidoping system, including carrying out doping control tests by anti-doping organisations. Border closures, flights cancellations, movement restrictions, lockdowns, office closures and generally cancellation of sporting events affected the way of work of anti-doping organizations.

In this regard AMADA actively responded to COVID-19 outbreak, as it related to its national anti-doping program. Comprehensive guideline for testing has been developed and updated, which covers a number of areas affected by COVID-19, in particular whereabouts information, sample collection process, sample collection personnel, equipment, transportation to laboratories. This guideline is being timely refined to reflect the evolving nature of the pandemic.

Education and Awareness

Promoting clean sport values and increasing public awareness in the field of anti-doping, and especially expanding the knowledge of the younger generation in this area, is of particular importance to AMADA. The aim is to instill clean sports values into the society by informing the members of the society about the potential dangers of doping and by discouraging them to use prohibited substances.

Education and awareness program is directed to inform the athletes about their rights and obligations, provide them with access to trustworthy and clear information which would enable them to make individual decisions based on clean and fair sports values, as well as to contribute to development of ethics-based behavioral abilities and support development of personal moral values among children and young athletes.

Based on these principles, AMADA has implemented an extensive education and awareness program in 2020. A number of training and awareness-raising activities have been transferred to a new, remote format due to the restrictions affected by COVID-19 pandemic.

Webinars on diverse topics were held and several awareness-raising sessions have been organized in the form of online answers to questions raised by athletes.

Materials related to remote anti-doping awareness-raising campaigns have been placed on the website, social media platforms and other Internet resources to ensure a greater audience outreach.



FAQ Platform

In order to ensure that all questions addressed to AMADA via social networks are answered, AMADA developed Frequently Asked Questions Platform. Capacity Building

In 2020, AMADA staff took part in several international events. Due to restrictions caused by COVID-19 pandemics, majority of events took place in online format. Major questions raised and discussed during webinars were related to upcoming changes to the World Anti-Doping Code which will come into effect in 2021.














Code Implementation

In order to implement and raise awareness of the changes to the World Anti-Doping Code 2021, AMADA adopted a four-stage Code Implementation Plan and completed within the year of 2020.

For awareness purposes, AMADA held webinars for athletes, their support personnel and national federations officials, and organized information sessions in online format. AMADA has established a Network of Coordinators from national federations to provide as many athletes and their support personnel as possible with the information on the Code changes, and has organized special trainings. At the same time, all materials prepared by AMADA on the changes to the Code and International Standards have been posted on AMADA's YouTube channel, website and all social network accounts. In order to draw the attention of the general public to these changes, AMADA organized an online meeting with media representatives and informed them about those changes in detail.

Network of Coordinators

In accordance with the requirements of the new International Standard for Education, AMADA has asked sports federations to appoint responsible persons to increase knowledge in the field of anti-doping, as well as to strengthen joint activities to combat doping and promote clean sports values. In response to this, 25 federations have appointed their coordinators who are in charge for anti-doping education. AMADA's Department of Education organized a training program for these coordinators on "Changes to the World Anti-Doping Code - 2021". At the end of the training, the assessment has been carried out to ensure the appropriate level of understanding

among those coordinators. Coordinators who successfully completed the assessment were awarded with certificates by AMADA. AMADA's Department of Education intends to use this Network of Coordinators to assess the needs of athletes and support personnel in anti-doping education, develop training programs tailored to these needs, and raise awareness to a much wider audience.

Information materials

To ensure that the general sports community is well aware of the new changes to the World Anti-Doping Code that will be in force from 2021, AMADA has developed and published information materials. "Prohibited List" which will come into force in 2021, has been translated into Azerbaijani and provided to sports federations (associations), organizations in the field of physical education and sports (Azerbaijan State Academy of Physical Education and Sports, National Institute of Sports Medicine and Rehabilitation, National Olympic and Paralympic Committees of the Republic of Azerbaijan). The Prohibited list had been published in the official gazette. At the same time Prohibited List and other relevant materials have been posted on

the website. Also information booklets on the changes to the World Anti-Doping Code were provided to relevant stakeholders.

Additionally, AMADA's Education Department posted a number of informational materials on social media platforms, as well as carried out an entertaining online quiz.

Educational programs in the field of antidoping in the Republic of Azerbaijan

Physical Education and Sports" provides the organizational-legal, socio-economic basis of activities in the field of physical culture and sports and the basic principles of state policy, ensuring the right of everyone to engage in physical culture and sports. Training of professionals in the field of physical education and sports in the country is carried out by the Azerbaijan State Academy of Physical Education and Sports (ASAPES). It is worth to note that since 2020 along with major subjects, the ASAPES also runs Master's program on anti-doping education, which is provided

The Law of the Republic of Azerbaijan "On by AMADA. The curriculum covers the history of the Anti-Doping Movement, the activities of the World Anti-Doping Agency, the World Anti-Doping Code, anti-doping rule violations, doping control process, prohibited list, therapeutic use exemptions and clean sports values.

International Standard for Education

According to new International Standard for Education AMADA developed Training Plan for 2021. The Training Plan includes detailed information about focus groups specifications, the limitations to the number of participants, timeframe of training sessions, requirements to training materials, monitoring and evaluation process of trainings.

Determined from discussions with officials from sport federations, support personnel and athletes, the Training Plan includes the following

Detailed information about anti-doping rule violations

Wide awareness among athletes about short and long term side effects of using substances for performance enhancing, supplements, prohibited substances and methods

Trainings of clean sport values for young athletes




Intelligence and Investigations

AMADA extensively fights against doping in sport by using a variety of intelligence gathering and investigative methods. It has the Investigation and Intelligence Policy and Procedures in place, which conform with the World Anti-Doping Code and International Standard for Testing and Investigations. AMADA invites athletes and the general public to cooperate in the fight for clean and healthy sport. In this regard, AMADA has created confidential and anonymous information sharing channels for those who expose athletes and other persons using prohibited substances and methods or otherwise violating anti-doping rules. These channels include a Speak Up platform on AMADA's website, as well as social media accounts, e-mail address and telephone connection.


As a result of some of received information, various actions are taken, including targeted tests. Moreover, certain cases require wide investigations. To this end, close cooperation with law enforcement bodies assist in detecting a violation. AMADA has mobilized all its resources to fight against doping in sport and uses different technological solutions. For its investigations, AMADA obtained and uses Social Net Shadow Dragon and IBM I2 Analyst Notebook for automatically mapping of social media accounts and network of affiliated entourage of a person being under investigations.

Results Management Process

Results Management is process encompassing the timeframe between notification of the athlete of potential anti-doping rule violation, through the charge until the final resolution of the matter, including the end of the hearing process at first instance or on appeal (if an appeal was lodged).

AMADA's Results Management process is managed by the Legal Department and is governed by the principles of fairness, impartiality, and timeliness. The mechanism for the resolution of anti-doping rule violation consists of AMADA's Case Management Commission managed by Legal Department and operationally and institutionally independent bodies of first and appeal instances (Disciplinary and Appellate Committees).


As a general rule, if athlete waives his/her right for a hearing or gives a consent for a sanction proposed by AMADA's Case Management Commission, then the decision-making body is considered as AMADA. Otherwise, if athlete disputes a case, then it is referred to Disciplinary Committee for hearing and decision-making with a right of the parties to appeal the decision to Appellate Committee. In cases of internationallevel athletes, the decision could be appealed to the Court of Arbitration for Sport (CAS) located in Lausanne, Switzerland.

Case Management Commission

Case Management Commission (CMC) is established to take necessary decisions on the possible anti-doping rule violations. It has the authority to determine relevant steps that applicable normative legal acts. need to be taken for the prosecution of possible anti-doping rule violations in accordance with applicable AMADA Anti-Doping Rules.

CMC acts in accordance with the Constitution of the Republic of Azerbaijan, the Law of the Republic of Azerbaijan "On the fight against use of doping substances and methods in sport", International Agreements to which the Republic of Azerbaijan is a State Party, Statute of AMADA, applicable World Anti-Doping Code and AMADA Anti-Doping Rules, its Statute and other



Forfeiture of Medals

All competitive results of the Athletes obtained on the date of a doping control shall be disqualified with all the resulting consequences including forfeiture of medals if they are found to have committed an ADRV and against whom a decision imposing consequences has entered into force. Additionally, instead of them, the places of athletes who have automatically achieved this result must be restored and corresponding medals awarded.

The main aim of doping control is to ensure the principle of fairness in sports, as well as protection of clean sports and athletes' rights. The results obtained by an athlete using prohibited substances and prohibited methods breach the principles of fairness and equal opportunities in sport, as well as rights of athletes participating in competitions. In addition to a vigorous fight against such cases, one of the important issues is the restoration of the rights

of other athletes participating in competitions. This is important in terms of sporting careers of other athletes, their rankings, and international competition opportunities. Therefore, results of athletes having used prohibited methods and substances, obtained in competitions where an ADRV has been committed, must be disqualified, and rankings should be rearranged by rotation. AMADA pursues the disqualification of results, prizes, medals and points obtained by athletes having committed ADRVs and rearrangement of rankings by rotation in cooperation with the Ministry of Youth and Sport of the Republic of Azerbaijan and related sports federations.

Legal Aid

The Convention for the Protection of Human Rights and Fundamental Freedoms entails a provision of a proper legal aid if the person who is charged and faced with the possible sanction has no sufficient means to pay for his/her defence. Purpose of the anti-doping proceedings is not to punish, but to make sure that justice prevails, and principles of the clean sport are protected.


One way of balancing requirements of antidoping system with necessity of protecting athletes is to provide athletes with a proper legal aid. In this regard, AMADA implements pro bono

According to the program, a legal firm which cooperates with AMADA provides pro bono legal assistance for athletes who found to have committed anti-doping rule violation and is in need of a free legal assistance.

Online Hearings

Due to introduction of strict quarantine regime aimed at prevention of COVID-19, online hearings of ongoing cases were conducted via Zoom and MS Teams platforms in order to meet procedural timeframes set by the World Anti-Doping Code and International Standards, as well as to avoid delays in consideration of cases by the Committees.

PROGRAM ON IMPLEMENTATION OF THE WORLD ANTI-DOPING CODE

STAGE

(January-March 2020)

At this stage, AMADA introduced an opportunity to its staff to go through the new changes to the World Anti-Doping Code and International Standards in detail. At the end of this stage, AMADA's departments have prepared presentations reflecting relevant issues to have been considered while amending laws, policies and procedures of the organisation required by the Code.

STAGE II

(April-June 2020)

After collecting all information from other departments, at first, Legal Department of AMADA commenced work on a package of proposals for amendments to the legislation.

Upon completion, those proposals were sent to WADA for review and approval. Once WADA's opinion was received, a package of proposals has been forwarded to relevant state bodies for a preliminary evaluation.

Proposed amendments to the Law No. 447-VQ dated November 29, 2016 on "The Fight Against the Use of Doping Substances and Methods in Sport" of the Republic of Azerbaijan aimed at incorporating new definitions and other rights and responsibilities envisaged in the 2021 World Anti-Doping Code into the domestic legislation.

During Stages I and II AMADA benefited from opportunities offered by 2021 Code Implementation Support Program (CISP).



STAGE III

(July-September 2020)

At this stage, AMADA launched work on the draft of required amendments to its Anti-Doping Rules as well as internal policies and procedures.

AMADA benefited from Model Rules for national anti-doping organizations published by WADA and adapted its provisions to the local requirements while drafting Anti-Doping Rules. During 2020, Anti-Doping Rules were revised three times and eventually approved by WADA. Anti-Doping Rules, both in English and Azerbaijani were published on the official web page of AMADA.

Apart from that, internal rules and procedures regulating testing, results management, intelligence and investigations, legal, education, protection of confidential information, etc. have also been revised.

STAGE IV

(October-December 2020)

Being a last stage, it encompasses close cooperation and mutual partnership with sports organizations, other bodies, athletes and athletes' support personnel. Stage IV envisages intensive seminars/webinars, personal consultations, and continuous cooperation.

AMADA scrutinized provisions of internal regulations, charters, statutes, and other regulative documents of national sports federations related to the fight against doping in light of their compliance with the World Anti-Doping Code and revised International Standards. AMADA prepared a separate package of proposals for each organization and presented them to relevant federations (associations).

International activity

AMADA actively participates at the international arena to promote clean sport. As a national anti-doping organisation, AMADA is always on the lookout for better ways to improve the delivery of its activities on domestic level and contribute to combating doping worldwide. AMADA trusts that mutually beneficial collaboration contributes both on domestic level and on a global scale.

AMADA is committed to clean sport and pays its high interest in the protection of the rights of athletes. Being a partner of global anti-doping community, AMADA actively contributed to the international anti-doping development in the

directions of gender equality mainstreaming, whistleblower protection, human rights, access of athletes to justice, development of national antidoping organisations and worldwide education. By its attitude towards clean sport and efforts aimed at the development of anti-doping, AMADA was invited to be a part of various international groups to work on the improvement of those antidoping directions. Thereby, AMADA's staff was selected to different ad hoc and working groups and other committees, as well as monitoring groups as experts.

Engagement and Partnership

Domestic Coordination

Guided by cooperation and coordinated approach, AMADA recognizes and embraces experiences of other stakeholders. In their turn, these stakeholders benefit from working with a single centralized organization to prevent the threat of doping.

AMADA combats all elements of the doping threat in an organized manner. This encompasses law enforcement bodies, customs and state border service organizations, regulatory

bodies, academic bodies, as well as sports and healthcare sectors.

AMADA keeps on strengthening links with the World Anti-Doping Agency and other international anti-doping organizations for developing collective capacity of anti-doping community so that Azerbaijani athletes are provided with the ability to compete on equal terms wherever in the world.



Ministry of Youth and Sport

AMADA has strong collaboration with the Ministry of Youth and Sport of the Republic of Azerbaijan, as the latter being a body governing the whole sport in the country, and one of the main stakeholders of Azerbaijani anti-doping community.





Olympic National and **Paralympic** Committees

Spirit of equal partnership and cooperation with National Olympic and Paralympic Committees are essential in the fight against doping in sport.







Law Enforcement Bodies

AMADA extensively carries out information sharing with the law enforcement bodies, in accordance with the law on anti-doping. It is related to the prosecution of anti-doping rule violations, as well as other doping control activities where necessary. Moreover, doping substances such as anabolic

steroids are often imported and distributed illegally on the black market. As one of the activities of AMADA to fight against illegal trafficking of doping substances, it joins efforts with law enforcement bodies such Ministry of Internal Affairs, INTERPOL National Central Bureau, State Border Service and State Customs Committee to coordinate an effective detection and prevention.



National Federations

Republic sport federations are organisations that govern each type of sport within their respective jurisdiction. In order to jointly fight with doping, as well as promote clean sport and educate athlete and their entourage, AMADA collaborates with all national federations and monitors their compliance with the Code and International Standards.

FIGHT AGAINST DRUG ADDICTION AND ILLICIT TRAFFICKING

AMADA conducts an anti-doping policy in the country and implements an anti-doping which includes awareness-raising activities among athletes of various sports and age groups.

Considering that some prohibited substances in the Prohibited List are drugs and psychotropic substances, AMADA holds seminars for athletes in this area and highlights the consequences of using prohibited substances, including drugs and psychotropic substances. Scope of activities of AMADA encompasses athletes, athletes' support personnel, as well as young people studying in sports schools. The events are held in sports federations, sports clubs, as well as other sports entities and educational institutions.

Pursuant to the Order of the President of the Republic of Azerbaijan dated December 25, 2020 AMADA was included in the list of enforcers of "State Program on Combatting Illicit Trafficking in Drugs, Psychotropic Substances and Their



Precursors and Drug Addcition of 2019-2024" approved by the Order of the President n. 1334 dated July 22, 2019. AMADA has been included in the State Program with the aim of organization of awareness-raising activities using modern teaching methods to get athletes acquainted with the problems associated with the use of illicit drugs and psychotropic substances, enhancement of a mechanism in this direction, cooperation with relevant institutions and application of existing international experience.

By joining the State Program, AMADA will deliver lectures and seminars, conduct awareness-raising activities among athletes, members of athletes' support personnel and at sports schools on combatting drug addiction and negative effects of drugs, as well as organize other public awareness events.

International relations

AMADA actively participates at the international arena to promote clean sport. As a national antidoping organisation, AMADA is always on the lookout for better ways to improve the delivery

of its activities on domestic level and contribute to combating doping worldwide. AMADA trusts that mutually beneficial collaboration contributes both on domestic level and on global scale.



World Anti-Doping Agency

The World Anti-Doping Agency (WADA) is an international independent agency composed and funded equally by the sport movement and governments of the world. Its key activities include scientific research, education, development of anti-doping capacities, and monitoring of the World Anti-Doping Code - the document harmonizing anti-doping policies in all sports and all countries. AMADA closely collaborates with WADA on its daily activities and participates on WADA's events and special working groups, which helps AMADA keep the country in compliance with the Code and International Standards, as well as to contribute to the fight against doping in sport globally.



UNESCO

Azerbaijan became a party to the International Convention against Doping in Sport of UNESCO on 23 July 2007. Convention represents that governments around the world have agreed to apply the force of international law to antidoping. Convention recognizes and helps to ensure the effectiveness of the World Anti-Doping Code (the Code), as well as provides the legal framework under which governments can address specific areas of the doping problem globally. In accordance with the compliance monitoring of UNESCO, Azerbaijan has set a National Compliance Platform which consists of AMADA, Ministry of Youth and Sport, Ministry of Internal Affairs, State Border Service, State Customs Committee, National Olympic Committee, and, accordingly, AMADA being a National Focal Point for domestic coordination of country's compliance.



Council of Europe

Anti-Doping Convention of Council of Europe entered into force on 01 March 1990. The Convention lays down binding rules with a view to harmonising anti-doping regulations. Azerbaijan ratified the Convention and its Additional Protocol thereto on 04 November 2003 and 11 February 2004, respectively. Consequently, they came into force in 2004. AMADA closely collaborates with the Monitoring Group of Council of Europe (T-DO) and Ad Hoc European Committee of the Council of Europe for the World Anti-Doping Agency (CAHAMA) by participating in the meetings and works, as well as its various working groups.



International Testing Agency (ITA)

On 12 July 2019 AMADA and ITA signed a collaboration agreement. AMADA's partnership with the ITA covers sharing of information and expertise in areas of testing, intelligence, athlete biological passports, and cooperation on other mutually interesting issues. The agreement also envisages AMADA acting as Sample Collection Authority on the ITA behalf, as per request. Signing of this agreement is a next milestone of development strategy as expansion of international cooperation network to benefit from expertise and ensuring the synergy between national and international anti-doping efforts to bring about better results.



Institute of National **Anti-Doping Organizations**

AMADA is a member of the Institute of National Anti-Doping Organizations. The Institute covers more than 100 national anti-doping organizations worldwide. Within the framework of the Institute, AMADA exchanges information with other organizations in the anti-doping field and participates in various anti-doping initiatives and projects.



NADOs and Sample Collection Authorities (SCA)

AMADA closely collaborates with other national anti-doping organisations and private sample collection authorities to effectively plan its testing and better exchange of information. AMADA signed collaboration agreements with NADOs of Turkey, Canada, Russian Federation, Belarus, Ukraine, Bulgaria, Moldova as well as renewed its agreement with the international sample collection organisation PWC based in Germany.



Media and Communications

Media Policy

AMADA considers mass media as an important tool in terms of anti-doping awareness. That is the reason why our organization seeks to take maximum advantage of traditional press and

social media. The purpose is to convey doping control and clean sport values to society in a holistic way.

Cooperation with media

AMADA's relations with media are built on the principles of transparency, efficiency, and accessibility of information. Notwithstanding the difficulties of COVID-19 pandemic, AMADA has regulated its media relations in line with requirements of quarantine regime. Press conferences and meetings with media representatives held online.

Throughout 2020 hundreds of news were published by media about AMADA's activities and anti-doping through television, digital platforms and newspapers.

AMADA organized the first ever online 'virtual café' for representatives of mass media on the National Press Day. This event focused on the principles that unite AMADA and mass media as well as the role that mass media can play in covering anti-doping issues and being actively involved in awareness.

September 5, 2020, On the International Charity Day, AMADA held an event at women's and children's shelter. As part of the event, food and items of hygiene were provided to the shelter. In addition, an intellectual - entertaining game for children was organised and gifts were presented to all children. At the same time awareness talks on ways to stay safe amid the coronavirus pandemic were held.

On September 24, 2020, AMADA held an extensive press conference on the spread and consequences of anabolic steroid use in society. AMADA CEO Shafag Huseynli, Head of the Sports Department of the Ministry of Youth and Sports Farid Mansurov, Director of the Organization of Inpatient Medical Services Department Kamala Agayeva and President of the Azerbaijan Federation of Sports Journalists Gabil Mehdiyev informed public about the emergence of this concern. It was noted during the event that the use of anabolic steroids, has become a serious problem for society, going beyond the boundaries of professional sports. The public was widely informed about the

consequences of anabolic steroids use without medical prescription and a video was shown in this regard. Participants discussed the causes of the spread of steroids, illicit trafficking, measures to combat it, the scale of the problem and the importance of the active participation of the public in this struggle, given its urgency.

AMADA held a press conference on December 22 dedicated to the results of 2020. During online event AMADA CEO Shafag Huseynli provided detailed information to the media about AMADA's activities and and projects.
